Semple & McKillop are accepting applications for industrial placement and internships. While the Programme is for 12 months, applications from students who require 6-8 months placement shall also be considered.

The successful student(s) shall have an interest in mechanical and/or electrical design of services within the built environment or electrical power engineering. S/he shall be completing a degree in Building Services, Electrical, Mechanical or other relevant Engineering degree.

The post holder shall:

- ◆ work under the direct supervision and mentorship of a Senior Chartered Engineer;
- ◆ join a strong Team of professional engineers across our offices;
- ◆ work on projects from initial concept through to completion;
- ◆ gain experience in client meetings, outline and detailed design, product specification, cost management and inspection of services on site;

- ◆ develop a knowledge of Building Information Modelling and skills in Autocad Revit and a wide range of specialist and modelling software.

2. An up-to-date **Curriculum Vitae**.
3. Details for **two referees**. One of these should be your Head of Department/Senior Tutor. The second should preferably be someone who can comment on your suitability for this Programme.

The above 3 requirements must be returned with your application for it to be considered.
